1. This Request for Expression of Interest follows the General Procurement Notice for the National Arts Council that appeared in News Papers in 2007.
2. The Government of the United Republic of Tanzania through the Ministry for Information, Culture, Arts and Sports under NATIONAL ARTS COUNCIL has set aside funds for the Financial year 2016/2017 towards the building of Artistical skills in the community and it intends to apply part of its proceedings be used to cover eligible payment under the contract for construction of Reviewed Open Air Theatre at BASATA.
3. The National Arts Council (BASATA) now invites sealed bids from eligible National Building Contractors registered in class V and above for construction of Reviewed Open Air Theatre at NATIONAL ARTS COUNCIL (BASATA).
4. Tendering will be conducted through the National Competitive Tendering Procedures specified in the Public Procurement Regulations 2013- Government Notice No. 446 and is open to National Tenderers only as defined in the Regulations unless otherwise stated in the Tender Data Sheet.

5. Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the : **Executive Secretary, National Arts Council (BASATA), P.O.BOX 4779, Dar es Salaam** from 08:00 am to 04:00 pm on Monday to Friday except on public holidays.

A complete set of Tendering Document(s) in English language and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and **upon payment of a non – refundable fee of Tshs. 100,000/= Payment should either be by M-PESA to No. 258877 National Arts Council or Cash deposited in Account 011103003009 NBC Bank or Banker’s Cheque, payable to National Arts Council.**
7. All tenders must be accompanied by a Tender securing Declaration in the formats provided in the Tendering Documents.
8. All Tenders in one original plus two copies properly filled in, and enclosed in plain envelopes must be delivered to the address:
The Secretary, Tender Board, National Arts Council, Ilala Sharif Shamba, P.O. Box 4779, Dar es Salaam, Tanzania at or before 10:00 hours local time, Friday 19th May, 2017. Tenders will be opened promptly thereafter in public and in the presence of Tenderer’s representatives who choose to attend in the opening at BASATA Conference Room.
9. Site visit will be conducted on 29/04/2017 starting at 10:00 am local time at the respective site followed by a re-bid meeting to take place at a respective area.
10. Late Tenders, portion of Tenders, Tenders not received, not opened and not read out in public at the bid opening ceremony and telegraphic, telex, telefax, bids or portion of any Bids shall not be considered for evaluation irrespective of circumstances.
11. National Arts Council (BASATA) is not obliged to accept the lowest or any bid.
